**Sub:- Compliance of the order dated 28.03.2014 of LD. CAT in OA. 1084/2014 titled Ms. Alka Vs DSSSB & Ors.**

The Hon'ble CAT in OA No. 1084/2014 titled Alka V/s DSSSB & Ors vide its order dated 28.03.2014 has directed as under:-

"3. An internal remedy has been sought which is awaiting a decision. The prescribed period for disposal of such remedy is also not over. Hence, the OA cannot be admitted at this stage. However, as the learned counsel states that there is urgency in the matter and also having regard to the fact that the representation is already pending of more than one and half months, we direct that respondent No. 1, shall dispose of the representation and pass a reasoned and speaking order and duly communicate the same to the applicant within a period of three weeks from the date of receipt of a copy of this order.

4. OA is disposed of with aforementioned directions. No costs."

In compliance of the above order, the case of applicant Ms. Alka Ref No.10000304 has been examined and it is found that:-

1. Board as per requisition of user department i.e. MCD had advertised 1610 (UR-879, OBC-470, SC-261) vacancies including PH\* (OH:26, VH:26) \*Includes as per horizontal reservation in UR/OBC/SC, for the post of Special Educator (Primary) in MCD, under Post Code 01/12, vide advertisement No. 01/2012 with closing date as 13/03/2012 (Cut-off date).

Later on vide **corrigendum dated 09.04.2013**, as per the requisition of the user department, the vacancy position was rectified as under:

**PH (OH) instead of PH (OH:26, VH:26)**

2. The applicant Ms. Alka had applied for the post of Special Educator (Primary) in MCD, under post code No.01/12, under VH category. The DSSSB had conducted the Interview for this post on 21.01.2014 and 22.01.2014 and the result for the post code was declared on 29.01.2014.

3. On the basis of academic record assessment and marks assigned in the interview by the Interview Board members, her case was carefully examined before the declaration of the final result, as such her dossier was scrutinized for determination of her eligibility for the post, with regard to fulfillment of the eligibility conditions i.e. age limit and educational qualifications for the post. On the scrutiny of the dossier/application, the applicant was found **over-aged in UR category** and **there is no reservation for VH category as per corrigendum dated 09.04.2013** issued on the basis of intimation received from the user department i.e. MCD.

In view of the above facts, the applicant Ms. Alka could not be considered for selection to the post of Special Educator (Primary) in MCD, under post code 01/12.

This issues with prior approval of the competent authority.
